## **COMPLAINTS AND SUGGESTIONS**

Save Penwith Moors is asking the Minister at DEFRA for a grazing exemption for the specific areas of Carnyorth Moor, Lanyon Farm (Men-an-Tol and Lanyon Quit Crofts), and the two National Trust properties of Watch Croft and Carn Galva. If this is granted then we ask that all new fencing, gates etc put up under the HEATH project (that are not replacement fencing) are removed.
